## ANNOUNCEMENT ISSUE OF UNITS TO MANAGER IN PAYMENT OF MANAGEMENT FEES

Parkway Trust Management Limited (“PTM”), the Manager of Parkway Life Real Estate Investment Trust (“PLife REIT”), wishes to announce that 333,541 new units (“Units”) are issued to PTM on 06 August 2009. The Units are issued at an average issue price of S\$0.88 per unit, in payment of 20% of the Manager’s management fee for the period from 01 April 2009 to 30 June 2009.

In accordance with the Trust Deed, the issue price was determined based on the volume weighted average traded price for a Unit for all trades completed on the Singapore Exchange Securities Trading Limited, in the ordinary course of trading, for the last 10 business days of the relevant period in which the management fee accrues.

Following the above issue of Units, the total Units in issue is 603,464,005, of which PTM’s holding is 2,046,005.
