 (a) Sunil Chandiramani is a controlling shareholder of Symphony Asia Pte. Ltd., which wholly-owns Symphony Asia Holdings Pte. Ltd., the investment manager to Symphony International Holdings Limited ("SIHL"). Britten Holdings Pte. Ltd. ("Britten") is a wholly-owned subsidiary of Lennon Holdings Limited ("Lennon"), and Lennon is a wholly-owned subsidiary of SIHL. Accordingly, Sunil Chandiramani has a deemed interest in the units of Parkway Life REIT held by Britten.  
 (b) Sunil Chandiramani is a controlling shareholder of SQR Limited, which wholly-owns all the voting shares in SQR Global Healthcare Services Fund I ("SQR GHSF I"). Accordingly, Sunil Chandiramani is deemed to have interest in the 160,976 units of Parkway Life REIT held by SQR GHSF I.
