Parkway Life Real Estate Investment Trust ("PLife REIT") issued and listed 47,369,000 new units on 1 November 2024 pursuant to its private placement exercise.

Mitsui & Co., Ltd.'s ("Mitsui") deemed interest in PLife REIT arises through its wholly-owned subsidiary, MBK Healthcare Management Pte Ltd ("MBKHM"). MBKHM holds more than 20% of the total issued share capital of IHH Healthcare Berhad ("IHH"). Accordingly, Mitsui has a deemed interest in PLife REIT units held by IHH.

IHH Healthcare Berhad's ("IHH") deemed interest in PLife REIT is held through the following wholly-owned subsidiaries:-

- (i) Integrated Healthcare Holdings Limited ("IHHL") - 219,215 of PLife REIT units;
- (ii) Parkway Investments Pte Ltd ("PIPL") - 213,257,000 of PLife REIT units; and
- (iii) Parkway Trust Management Limited ("PTML") - 1,494,486 of PLife REIT units.

Both PIPL and PTML are wholly-owned subsidiaries of Parkway Holdings Limited ("PHL"), a wholly-owned subsidiary of Parkway Pantai Limited ("PPL"). PPL is a wholly-owned subsidiary of IHHL, which is in turn wholly-owned by IHH. Accordingly, IHH has a deemed interest in units, direct and deemed, held by IHHL, PIPL and PTML.
