ANNOUNCEMENT PURSUANT TO RULE 706A OF THE LISTING MANUAL

Pursuant to Rule 706A of the Listing Manual, Parkway Trust Management Limited, in its capacity as manager of Parkway Life Real Estate Investment Trust ("**PLife REIT**", and as manager of PLife REIT, the "**Manager**"), wishes to announce the following transactions carried out during the period from 1 July 2024 to 31 December 2024:

ACQUISITION

The Manager refers to:

- (a) its announcement dated 22 October 2024 titled "Acquisition of Eleven Nursing Homes in France" (the "22 October 2024 Announcement"), where the Manager had announced, *inter alia*, that PLife REIT's wholly-owned Singapore subsidiary, Parkway Life Nova Pte. Ltd. had entered into a promise of sale and a contract for transfer of shares to acquire 11 nursing homes in France (the "Properties") from the DomusVi Group (the "Acquisition"); and
- (b) its announcement dated 20 December 2024 titled "Completion of the Acquisition of Eleven Nursing Homes in France" (the "20 December 2024 Announcement"), where the Manager had announced, *inter alia*, that the Acquisition had been completed.

The purchase price for the Properties is approximately €111.2 million (approximately S\$159.9 million) (the "Purchase Price") which was arrived at on a willing buyer and willing seller basis and based on the independent valuation of the Properties by Cushman & Wakefield Valuation France.

The Purchase Price was fully funded via equity fund raising by way of a private placement. Please refer to the announcement dated 20 December 2024 titled "Use of Proceeds from the Private Placement" for further details.

The following subsidiaries of PLife REIT were incorporated/acquired in connection with the Acquisition.
