ISSUE OF UNITS TO MANAGER FOR PAYMENT OF MANAGEMENT FEES**

Parkway Trust Management Limited ("PTM"), as manager of Parkway Life Real Estate Investment Trust ("PLife REIT"), wishes to announce that 33,901 new units in PLife REIT ("Units") are issued to PTM on 14 November 2025. The Units are issued at an average issue price of approximately S\$4.11<sup>1</sup> per unit, being part payment of base fee component of the management fee<sup>2</sup> due to PTM for the period from 01 July 2025 to 30 September 2025.

In accordance with the trust deed constituting PLife REIT dated 12 July 2007 (as amended, the "Trust Deed"), the issue price per Unit was determined based on the volume weighted average price for a Unit for all trades completed on the Singapore Exchange Securities Trading Limited ("SGX-ST"), in the ordinary course of trading on SGX-ST, for the period of ten business days immediately preceding the last business day of each month of the relevant period in which the management fee accrues.

Following the above issue of Units, the total Units in issue is 652,486,974, of which PTM's holding is 1,462,774.
